6.1 **2012/4189- 63, Stevens Lane**—TPO EL: 92/12-Tree 2-remove storm damaged branches, reduce selected branches; Tree 3-reduce height to 10.5 m, reduce selected branches. No comment

6.2 **2013/176-29**, **Foley Road** – *first floor front extension*

We are not objecting but ask that the side windows are of obscure gazing and non-opening or are high-level.

- 6.4 **2013/74- 3, Thorne Close**—TPO: EL: 89/25-sycamore (T1) remove limb growing from east stem, limb growing from west stem and limb growing from west stem to round east stem at 9m No comment

6.7 **2013/328 –26, The Roundway** – two storey side/rear extension and front porch

We are not objecting, but ask the Officer if there will be sufficient amenity space if the application is granted.

Re application 2012/4585 –land to South West of Woodlands House and Greenways, Hillview Road – 2 additional detached two storey houses with rooms in roof space, rear dormer windows, detached garage block and new access via the cul-de-sac between 5 & 6 Ruxley Ridge.

This was discussed at the last meeting. One objector, Mr Carney, submitted a tree report from an independent person to EBC. A senior officer at Elmbridge confirmed that the independent tree report from Ian Keen Ltd is a "substantial objection to this proposal on tree grounds" and as a consequence it is appropriate to defer the application at the next EA Sub-Committee to allow the Tree Officer to consider the points in it. Consequently the application has been deferred from 18th Feb to 11th March.

It was agreed that this Committee would review the report (although Cllr Huddart had read it prior to the last meeting). The report was reviewed and it was agreed that the comments made at the last meeting were still valid. Consequently, no changes will be made to the comments submitted by this committee to EBC. The Clerk will inform Mr Carney.

Cllr Huddart has received a copy of an application 2013/359-1, Sims Cottage dated 13 Feb. 2013. The plans were not complete and this application was not on the weekly list. It was agreed to inform the Officer in charge of the application that he will not receive comments from CPC until after the next planning meeting, which will be after the 21 days submission date.

7. Report of the East Area Sub Committee

Cllr Hayes attended and gave an oral report to the meeting. There was one application for Claygate-2012/4303-33, Red Lane-this was permitted.

9. Enforcement

Cllr Isaacs gave an oral report to the meeting.

Claygate Manor – Enforcement officer Terry French has now returned to work. He is also responsible for s.106 payments so is currently catching up with that. He will be involved with CIL charging and is currently undergoing training sessions for this, so no work has been carried out on Enforcement issues. It is known that activity has begun again at Claygate Manor as transit vans have been seen entering the site at different times of day and night. It was agreed that Cllr Isaacs will inform Terry French of these new developments tomorrow. It was recommended that Cllr Isaacs start an email log of communications with Enforcement Officers so that we have records.

Post meeting report: A Claygate resident has been in contact with the EBC enforcement team for nearly 3 years and CPC about 20 months. The progress during this time has been non-existent. The owner of Claygate Manor has not been seen at the property for nearly a year. Unit 2 is currently being used by a tree surgeon who is living on the premises in a caravan with his partner and small child. Their van is seen regularly coming and going at all times of day and night. He has been on the property for about 6 months.

There is also a landscaping firm using the two end units, he is seen daily using the road.

There are two 4 wheel drive vehicles with trailers regularly seen using the premises. One appears to be storing/moving collapsible tables used for function events; the other has reclaimed architectural salvage that he is storing there. These are seen once to twice a week.

Vans are being stored to the rear of the barn.

The huge electric gates are still there, having been refused planning permission; still hindering access to the land to the rear of the estate for farming and access to a mobile transmitter tower. These gates are on a road not owned by the owner of Claygate Manor.

1, Woodlands Close – no report as Cllr Isaacs was unable to contact the Officer. **Oakhill** – (Enforcement officer Tom Scriven) – more information is awaited.

It was agreed that the level of Enforcement is not satisfactory at the moment. It is known that Terry French was absent from work for some months due to illness, and that a new Enforcement officer will be employed-however, the situation is unsatisfactory. It was agreed that the Clerk and Cllr Isaacs will draft a letter to Richard Morris about the situation.

Cllr Huddart raised a matter he wished discussed; that it is important for transport issues to be included in the Settlement ID plans because county councils are ignoring local transport issues. Cllr Isaacs will also mention about the recent problems with Enforcement and the recent trend for applicants to apply for planning permission and also an LDC at the same time- thus getting larger amounts of development. Cllr Isaacs requested that any other issues are communicated directly to her prior to the group.
